## **Ending Poverty, Advocating for RACIAL, GENDER, AND ECONOMIC JUSTICE**

GHLA attorneys work to improve the circumstances for people living in poverty and to strengthen our community. We increase safety from violence, preserve housing, stabilize income, improve health, and expand educational opportunity. We understand that more people of color and women live in poverty because of structural racism and sexism, and that bias can reduce options and opportunities. To address the harm, we focus on priorities and strategies that advance equity, reduce poverty and grow opportunity.

# RESULTS



## SAFETY

Civil legal remedies offer important safety options for victims living in poverty, and an alternative to criminal legal system responses.

**Launched** the **Domestic Violence Restraining Order Project** in Hartford's Family court, the state's busiest restraining order docket. GHLA's lawyers coordinate with Interval House domestic violence program to address the complex legal, family and safety issues of domestic violence victims.

**Attained** a no contact Restraining Order for a client whose partner, following their breakup, shot at her home and threatened to kill her and her family.

## HOUSING

**Launched** **Greater Hartford's Eviction Right to Counsel Program**, as part of the Statewide Eviction Right to Counsel program (CT-RTC)– serving 60% more low-income tenants facing eviction than the pre-pandemic average. Across the state 69% of CT-RTC clients statewide identified as female, and more than 75% of CT-RTC clients identified as people of color.

**Helped** a survivor of domestic violence who works as a home health aide and raises four children on her own to keep her apartment and her Section 8 housing subsidy.

## BENEFITS

Government benefits are limited and can be difficult to access for some who need them. GHLA's advocacy resolves access issues for eligible individuals and works systemically to expand access and increase these essential resources.

**Restored** SNAP benefits for a three-generation household after they were all stricken with COVID and could not document the son's last date of work at a fast food restaurant.

**Attained** a significant change in the Temporary Family Assistance program standards– from a regional “standard of need” (SON) to a statewide eligibility standard tied to the federal poverty level (FPL), in partnership with the statewide legal aid network— resulting in increased cash benefits for all very low-income people in the program.

# RESULTS



## EDUCATION

**Assisted** a 12 year old non-binary student with a history of being bullied, family loss, school avoidance, and trauma, in attaining a diagnostic placement at a clinical therapeutic school.

**Advocated** successfully to change the laws and program structures to make Connecticut's technical schools system more welcoming and supportive of students with disabilities.

## SECOND CHANCES



**Obtained** a pardon of a criminal record for a single mother of two – getting a pardon will allow her to get her RN license after she finishes nursing school.

**Obtained** a pardon for a middle-aged man, who can now become a full-time firefighter in the town where he is on training/provisional status.



## COMMUNITY EMPOWERMENT

**Provided** legal advice and crucial information to clients and community partners at sites across Greater Hartford including Enfield Social Services Department, Hands on Hartford, Hartford Police Department Homeless Outreach Van, Hartford Public Library, Manchester Community College, Mi Casa Family Services/Hispanic Health Council, Open Hearth Shelter, and South Street Church.
